" ORDER "

OMAN TAYI is appointed on adhoc basis to the post of Domiciliary Health Visitor (**DHV**) w. e. f. his/her date of joining in the scale pay of Rs.3050-75- 3950-80-4590/- P.M. plus other allowances admissible under rules from time to time in Arunachal Pradesh under following terms and conditions.

(1) The offer of appointment is on purely adhoc basis and will continue as such until further order and subject to fulfillment of the following condition.

He/She will have to produce 2 (two) certificates antecedents/character from Gazetted Officer under the Government.

(2) He/ She will have to produce a medical certificate from Govt. Gazetted Medical Officer not below the rank of Civil Surgeon/ CMO/ DMO to the effect that he /she is fit for Government duty.

(3) The appointment is purely on adhoc basis and may be terminated at any time without assigning any reason.

(4) No TA/ DA are admissible for joining the post.

(5) The candidate is directed to report to respective head of Office/ DMO within a period of 21 (twenty one) days of issue of this order.

(6) The other terms and conditions of service which are not specified herein will be governed by the relevant rules and orders applicable for adhoc service in force from time to time in Arunachal Pradesh and decision of the DHS will be final in this regard. The certificate in original (education qualification, ST status etc) is to be shown to head of office before joining report is accepted.

(7) He/She is placed at the disposal of District Medical Officer, East Kameng District, who will determine & intimate the suitable location of his /her posting place.
