TERMS AND CONDITIONS OF APPOINTMENTS.

1. The post is transferable and liable to serve in any part of Arunachal Pradesh where the Department is having such Establishment.
2. The appointment has been initially made on probation for period of 2(two) years with effect from the date of joining at the place of posting, further retention of their services beyond the probation period are subjected to satisfactory performances of duty during the probation period.
3. Inter-Se-Seniority will be fixed in accordance with relevant rules later.
4. At the time of joining duty He/She should furnished certificate of physical fitness from a Medical Officer not below the rank of DMO Civil Surgeon/CMO etc.
5. At the time of joining duty He/She should take oath of allegiance to the constitution of India and sign other documents as required under the rules.
6. Their retention in service is subjected to verification of Character and antecedent and satisfactory performance of their duties.
7. Other conditions of service which are not specified herein shall be governed by the rules and orders of Government in force from time to time.
8. The appointees should report to their places of posting within 30(thirty) days from the date of issue of this order failing which this offer of appointment will be treated as cancelled.
