TERMS AND CONDITIONS OF APPOINTMENT

1. The appointments are purely temporary and liable for termination at any time by serving one month's notice from either side.

5. Their retention in service is subject to verification of their character and antecedents and satisfactory performance of their duties.
6. Other conditions of services which are not specified herein shall be governed by the rules and orders from Govt. in force from time to time.
7. The appointee should submit intact attested 2 passport size photographs showing the full name and signature in the backside of photograph at the time of their joining in the place of posting for verification.
8. The appointees should report to their place of posting within 30(thirty) days from the date of issue of this order failing which this offer of appointment will be treated as cancelled.
