TERMS AND CONDITIONS OF APPOINTMENT

- The appointments are purely temporary and liable for termination at any time by serving one month's notice from either side.

2. Inter se-seniority will be fixed in accordance with the relevant rules later.
3. At the time of joining duty they should furnish certificates of physical fitness from a Medical Officer not below the rank of DMO/ Civil Surgeon/CMO etc.
4. At the time of joining they should take oath allegiance to the constitution of India and sign other documents as required under the rules.
5. Their retention in service is subject to verification of their character and antecedents and satisfactory performance of their duties.
6. Other conditions of services which are not specified herein shall be governed by the rules and orders from Govt. in force from time to time.
7. The appointees should submit latest attested & passport size photograph 2 (Two) copies showing the full name and signature in the backside of photograph at the time of their joining in the place of posting for verification.
8. The appointees should report to their place of posting within 30 (thirty) days from the date of issue of this order failing which this offer of appointment will be treated as cancelled.
