The appointment to the post of Sub-Inspector in APP (Civil Police) shall be subject to the following conditions:-

1. Will have to under go Police Basic Training at recognized Police Training Centre as ordered by the authority concerned and ensure proper attendance and discipline in the training Institute
2. Successful completion of basic training.
3. The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
4. Will be on probation for a period of two years.
5. Will be required to serve at least for 3 years from the date of joining, unless discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he/she has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training school.
6. They are required to serve anywhere in Arunachal Pradesh where posted or detailed as well as out side of the State if deployed.
7. The inter-se seniority in the rank of Sub-Inspector in respective cadre will be determined on the basis of marks obtained on conclusion of the basic training.

The other terms and conditions of service which are not specified herein shall be in accordance with the relevant rules in force from time to time.
