He should report to the Jt.DHS (T&R),Pasighat for duty within 30(Thirty) days from the date of issue of this order failing which the appointment shall automatically stand cancelled. No further correspondence will be made in this regard.
5. All MTS posts are district specific.No representation for inter-district transfer shall be entertained.
6. The other terms & conditions which are not specified herein will be governed by the relevant rules & orders in force from time to time in Arunachal Pradesh.


