The Governor of Arunachal Pradesh is pleased to appoint Sri R.K. Taj as Soil Scientist (Scientist - SC) (Group A) (Gazetted) in the Department of Environment & Forest, Govt. of Arunachal Pradesh in the pay scale of Rs. 8000-275-13500/- Pm plus other allowances as admissible under Rules from time to time with effect from the date he reports for duty to the Director, SFRI.

2. The officer is posted to the establishment of Director, SFRI with his headquarters at Chimpu, Itanagar.
3. His appointment is purely temporary and he will be on probation for a period of 1(one) year from the date he reports for duty at the place of posting.
4. This appointment is liable to be terminated at any time on one month's notice from either side without assigning any reason. The appointing authority, however, reserves the right of termination of service of the appointee forthwith before the expiry of the stipulated period of notice by making payment to you a sum equivalent to the pay & allowances for the period of notice or the unexpired portion thereof, if any.
5. He will have to serve at any place in Arunachal Pradesh as and when required/directed by the Govt./Competent Authority.
6. He should take oath of allegiance to the Constitution of India duly in prescribed form before the Director, SFRI.
7. The other terms & conditions of service which have not been specified herein will be governed by the relevant rules and Regulations/ orders issued by the Govt. from time to time.
