- He/She will not be entitled to Special Compensatory Allowance, Winter Allowance, Medical Re-imbursement, Children Education Allowance, Re-imbursement of Tuition Fees, Level Travel 3. Concession (LTC), and any other advances as permissible to other regular Govt. servants.
- He/She is not entitled to subscrop to GPF or CGEIS or such other welfare schemes during the 4 period of contract service.
- He/She have to report at the given posting place within 7 days from the date of joining in the 5. DPO Office, failing which his/her engagement order will automatically be treated as cancelled.

- He/She will have to under go any training for any duration as and when called for. He/She is 7 also to work as Volunteer Instructor of the Total Literacy Campaign for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
