4. He is posted at Nari Under DMO Pasighat.
5. He should report to the respective District Medical officer for duty within twenty days from the date of issue of this order failing which the appointment will be automatically stand cancelled. No. further correspondence will be made in this regards.
6. The other terms & conditions which are not specified herein will be governed by the relevant rules & orders in force from time to time in Arunachal Pradesh.
7. The appointment is subject to regularization through D.P.C.


