MEMORANDUM

Sub: - Offer of appointment to the post of Forest Guard.

As approved the select list by the State Govt. vide letter No. FOR.304/E-1(B)/2006/Vol-III/7716-17 dtd. 14-01-2016, Sri Marbom Ngomle, (Roll No. A - 2630) is hereby offered an appointment to the Post of Forest Guard in the Department of Environment & Forest, Arunachal Pradesh.

The terms and conditions of the appointment are as under: -

1. The appointment to the post of Forest Guard shall be purely temporary and on probation for 2 (two) years. During the probation period your service may be terminated at any time without any notice/ assigning any reasons. After satisfactory completion of the probation period, termination from service may be effected by giving 1 (one) month notice from either side. However, the appointing authority reserves the right of termination of service forthwith as even before the expiry of the stipulated period of notice by making payment of a sum equal to his pay for the unexpired period of the notice.
2. The appointment is on the condition that the candidate should undergo compulsory Forest Guard Training in the Arunachal Pradesh Training Institute, Roing in the next session and without completion of the training in the next session the services will stand automatically terminated.
3. The scale of pay of the post of the Forest Guard is ₹5200- 20, 200+ GP 1,800/- PM. The initial pay will fixed at the minimum at this scale as per rules.
4. The Dearness and other allowances will be the same as admissible to the Arunachal Pradesh Government Servants of the corresponding status stationed at the place of his duty.
5. After satisfactory completion of probationary period, you will be required to contribute compulsorily to the General Provident fund in accordance with the rules in force from time to time.
6. You will have to an Oath of Allegiances to the Constitution of India and make a solution affirmation to the effect in the prescribed form before a Controlling Officer.
7. The appointment shall be subject to satisfactory reports on Character and Antecedents which will be done within the period of probation and, if any, adverse report is received from the Police/ District Authority, your service will be terminated forthwith.
8. You are not entitled to any traveling allowance for joining the appointment at your place of posting.
9. The other terms and conditions which are not specified herein would be governed by the rules and orders that may be in force from time to time by the Government.
10. You are required to produce the following documents to the office of the undersigned without which joining report will not accepted.
 - i) Attested copies of Educational qualification certificates. The original certificates will be returned after verification.
 - ii) 2 (two) character certificate in original from 2 (Two) different group - A Gazetted Officer from Central Government or State Government.
 - iii) Medical certificate of fitness in original from Group-I Government Medical Officer.
 - iv) 2 (two) attested copies of age proof certificate with original. The original certificates will be returned after verification.
 - v) Attested copies of Arunachal Pradesh Schedule Tribe certificate from the Deputy Commissioner of the concerned District with original in case of APST candidates.
 - vi) 2 (two) identical prints of latest passport size photograph duly attested by Gazetted Officer.
11. You are required to convey your written willingness to accept the offer to the Chief Conservator of Forests, Southern Arunachal Circle, Deomali, Arunachal Pradesh within 20 (twenty) days from the date of issue of this offer failing which it will be presumed you are not interested in this post and this offer of appointment will be treated as cancelled.
