## <u>ORDER</u>

Miss Tiye m Pertin is hereby engaged as A/T(A) Hindi on contract basis in the fixed pay of Rs.7200/- (Rupees seven thousand two bundred) only with effect from the date of joining in the concerned school up to 15/04/2007 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/she is posted at Govt. Primary School, Kiyit.

The engagement is subject to the following conditions:-

- The contract teacher has no right to claim for regular appointment/regularization of a) the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service b) Leave Rule as pier terms and condition mentioned in the agreement copy:
- During contract service period he/she is not entitle for medical reimbursement; c) winter allowances; children educational allowances; reimbursement of tuition fees, leave travel concession (LTC); special compensatory allowances etc.
- The contract teacher have to report his/her duty at posting place within 7 (seven) d) days from the date of joining in the office of the concerned DDSE, failing which his/her engagem ent order will automatically be treated as cancelled.
- He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the e)
- The engaged teacher is also to work as volunteer instructor for TLC programme for f) the interest of literacy in Armachai Pradesh in addition to his/her normal duties.
- No representation will be accepted for change of posting place. g)
- He/she will have to under gone DIET training at concern DIET for Training as and h)
- The other terms and conditions of services which are not specified shall be governed i) by the relevant rules and order in forced time to time.
- The engaged teacher has to sign an agreement for contract engagement before j)
