1. The provisional appointment will be for a period of 6 (Six) months from date of their joining in service.
2. The candidate so appointed shall have to report for duty within one month from the date of issue of this order failing which the appointment shall stand cancelled.
3. The candidate appointed are liable to serve in any place of Arunachal Pradesh.
4. No traveling allowances will be allowed for joining at place of posting.
5. Other terms and condition which are not mentioned in this order shall be governed by rules and regulation in force from time to time.
6. The appointees are to submit medical fitness certificate at the time of joining for duty, from the medical board recognized by Govt. of Arunachal Pradesh.
7. Taking an oath of allegiance and faithfulness to the Constitution of India (or making of a solemn affirmation to that effect) in the prescribed form on joining..
8. In case, the character of the candidates is found not verified or any false information is given in his/her self declaration, this appointment order will be cancelled forth with and other criminal/legal action will be initiated as deemed fit.
9. Formal appointment order will be issued on receipt of police verification report from respective Superintendent of Police.
10. The appointees shall be on probation for a period of 2 (two) years from the date of their joining after which appointment will be confirmed on satisfactory completion of the period of probation.
11. Other terms and condition of service will be governed by the relevant rules and orders in force from time to time.
