#### ORDER

### TERMS AND CONDITIONS

- 1. The appointment will be effective only from the date of joining in its respective place of posting. Pay & allowances will be drawn prospectively.
- 2. The appointees shall be on probation for a period of 3 years as per APHS RULES- 2000 Section 10(1) from the date of their joining. Appointment will be confirmed only after satisfactory completion of the probation period on their initial place of posting.
- 3. The appointee should report for their duties at their respective place (s) of posting (s) within two weeks from the date of issue of this order, failing, which it will be presumed that he/she is not willing to join the post and accordingly the appointment shall stand cancelled.
- 4. The appointees shall serve in rural areas compulsorily for a minimum period of 5 years in any part of Arunachal Pradesh as per Govt. order.
- 5. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material, he/ she shall be liable for removal from service and such other actions as deemed necessary by Govt. of Arunachal Pradesh.
- 6. The appointee should appear before the State Standing Medical board within a period of 2 months after joining the service.
- 7. Those who are already in Govt. service and examined by Standing Medical Board need not, however, produce fresh Medical Certificate:
- 8. No request for change of place of posting will entertained.
- 9. Private practice of any kind whatsoever including laboratory and consultancy practice are prohibited as per sections 10 sub-sections 13 of the APHSR-2001.
- 10. No TA/DA will be allowed while joining on 1st appointment.
- 11. No permission for study leave with or without pay will be allowed before the completion of Probation Period. Any such attempt will entail termination from service.
