(Jr.) EPI is appointed on officiating basis on compassionate ground to the post of Health Assistant (Jr.) EPI in the Medical Department, Govt. of Arunachal Pradesh with effect from the date she report for duty on the pay of Rs. 3050/- P.M. in the scale of Pay Rs. 3050-75-3950-80-4590/-P.M. plus other allowances as admissible under Govt. of Arunachal Pradesh rules from time to time. Their pay and allowances will be drawn under the Head of Accounts-2211-Medical & Public Health (Non-Plan) B(b)06-101 (2) EPI B(b) 06-101 (2) (1)-Salary, Demand No.15.

The offer of appointment is subject to fulfilment of the following conditions :

1. She will have to produce two Certificates of Character and antecedents from Gazetted Officer under Govt. or from stipendiary Magistrate (Certificate from educational authority or from honorary Magistrate will not suffice).
2. She will have to produce a Medical Fitness Certificate from a Govt. Medical Officer not below the rank of civil surgeon/CMO/DMO to the effect that she is fit for Govt. Services.
3. The appointment is purely temporary and may be terminated at any time without assigning any reason giving notice for 1(one) month. If she wants to resign from service she will have to give 1(one) month notice to the Govt.
4. No TA/DA is admissible for joining the post.
5. She should report to District Medical Officer, Ziro for duty within 1(one) month from the date of issue of this order, failing which, the appointment will be automatically cancelled. DMO is requested to get the primary training on EPI/MCH and FW etc. for a period of 3(three) months at District Hospital, Ziro.

6. The other conditions of services which are not specified herein shall be governed by the relevant rules and orders in force time to time in Govt. of Arunachal Pradesh.

7. She is posted to District Hospital, Siro.
