ORDER

The following candidates are hereby declared selected and approved for appointment as Resource Person for Inclusive Education for CWSN under the head 'Academic Support through BRCs / URC', on contractual basis, in the BRCs and districts mentioned against their names, in the fixed pay of Rs. 26453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only till 31st March 2018, under the centrally sponsored scheme of SSA. Further they are directed to report to the Deputy Director of School Education of West Siang District for joining their duties in the BRCs mentioned against their names as per contractual norms of SSA.

The appointment is subject to the following conditions:-

1. Their contractual service is purely temporary and can be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
2. They have no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
3. They have to submit RCI Registration number to the office of the State Project Director, SSA Rajya Mission, Itanagar within 3 month from the date of appointment, failing which their appointment will be treated as cancelled.
4. The Marksheets / Certificates submitted by them for consideration are subject to verification from original source. In case of the forged Marksheets / Certificates they are liable to face legal action as per CCS Rule.
5. No earned leave is permissible except 12 days casual leave as per temporary central civil service leave rule.
6. During contract service period they are not entitled for medical reimbursement, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
7. The contract resource persons have to report for their duty at posting place within fifteen days, failing which their appointment order will automatically be treated as cancelled.
8. They are not entitled to subscribe GPF, CGEIS or such other schemes during the period of contract service.
9. No representation will be accepted for change of posting place.
10. They will have to undergo for RPs training as and when call for.
11. The other terms and conditions of service which are not specified shall be governed by the relevant rules and order in forced time to time.
12. The selected Resource Persons have to sign an agreement for contract service before receiving the appointment order.
