ORDER

Miss **Kenter Loyi** is hereby appointed as Full Time Teacher on purely contract basis in the fixed pay of 20000/- (Rupees Twenty thousand) only for the period of six months with effect from the date of joining in the concerned posting place against centrally sponsored scheme of **Sarva Shiksha Abhiyan**, created against the residential schools.

She is appointed in place of **Miss Depi Kamduk** and posted at **Govt. 100 Girls Residential School, Gori.**

The appointment is made subject to the following terms and conditions -

1. The engagement is a purely temporary basis and may be terminated from service anytime without assigning any causes/notice considering his/her performance of service.
2. The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contractual period.
3. No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
4. During contract service period he/she is not entitled for medical reimbursement, winter allowances (LTC), special compensatory allowance except fixed pay of Rs. 20000/- per month.
5. The appointee has to report his/her duty at concerned posting place within 7 (seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as canceled.
6. He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
7. No representation will be accepted for change of posting place.
8. The other terms and condition of service which are not specified here in shall be govern by the relevant rules and order in force from time to time.
9. The appointee on contract basis has to sign an agreement for contractual appointment at the time of receiving his/her appointment order copy.


