The Governor of Arunachal Pradesh offers Shri/Smt. Stacie Jamoh the post of APCS (Jr) under the Government of Arunachal Pradesh in the scale of pay of Rs.2000-60-2300-EB-75-3200/- P.M. The appointee will also be entitled to draw dearness and other allowances including the special compensatory allowance while posted beyond the Inner Line Boundary in Arunachal Pradesh at the rates admissible under and subject to the conditions laid down in, rules and orders governing the grant of such allowances in force from time to time.

The terms of appointment are

- (a) The appointment will be on probation for a period of 2 years.
- (b) The appointment may be terminated at any time by a month's notice given by either side, viz, the appointee or the appointing authority, without assigning any reason. The appointing authority however reserves the right of terminating the services of the appointee forthwith or before the notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- (c) The appointment carries with it the liability to serve in any part of India including Arunachal Pradesh.
- (d) Other conditions of service will be governed by the relevant rules and orders in force from time to time of Arunachal Pradesh Civil Services (Jr).

3. ther subject to :-

- (a) Production of a Certificate of fitness from the Medical Board, appointed/authorised by the Govt. of Arunachal Pradesh. Those who are already in Govt. service and examined by standing Medical Board need not, however produce a fresh Medical Certificate.
- (b) Submission of declaration in the form enclosed (annexure-I) and in the event of the candidate having more than one wife living or being married to a person having more than one wife living the appointment will be subject to his being exempted from the enforcement of the recruitment in this behalf.
- (c) Taking an oath of allegiance faithfulness to the constitution of India (or making of a solemn affirmation to that effect) in the prescribed form on joining.
- (d) Production of the release order from the previous employer (applicable in the case of persons who are new in Govt. Service)
- (e) Any training as and when assigned to them by the Govt. must be attended without fail.

4. It may please be stated whether the candidate is serving or is under obligation to serve, another Central govt. Department, a State Govt. or a Public authority.

5. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have wilfully suppressed any material information he/she will be liable to removal from services/discharge from probation and such other action as Govt. may deem necessary.
