However, the appointing authority reserves the right for terminating the service of the appointee forthwith on or before the expiry of stipulated period of notice by making payment to her/him sum equivalent to the pay and allowances for the period of notice by the unexpired portion thereof.
4. The appointee shall produce medical fitness certificate from an authorized Medical Officer at the time of joining his duties.
5. The appointee shall take an oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.

The other terms and conditions which are not specified herein shall be governed by the relevant rules and orders that may be in force from time to time.


