OFFICE ORDER

On recommendation of the DPC held on 1st July 2021 **Shri Rigge Gara**, is offered the post of **Work Charge (Temporary) Surveyor** as promotee on purely temporary basis on the following condition :-

1. Scale pay (L-4) Rs. 25,500-81,100/- P.M. and plus other allowances as admissible under Rule
2. The appointment will take effect from the date he/she actually joins the place of posting and the length of service put in as casual employee shall not be counted.
3. His/Her age shall not have been less than 18 years and not more than 30 years on the date of his/her engagement in the department as casual labour. (There shall be relaxation of 5 years in upper age limit in case of ST/SC candidate).
4. He/She shall be liable to serve in any place wherever Arunachal Pradesh PWD operates.
5. His/Her appointment will be purely Temporary and liable to termination on one month's notice from either side.
6. He/She shall have to take oath of allegiance to the Constitution of India on the date of joining.
7. He/She shall have to produce a character certificate from the District Sub-Divisional Magistrate or from a Gazetted Officer known to him/her for 3(Three) years prior to this appointment.
8. He/She shall be on Probation for a period of one year.
9. Original Certificate and testimonials in support of his/her qualification and age if he/she belongs to Schedule Caste/Schedule Tribe, a certificate from a Magistrate or Commissioner for Schedule Caste/Tribe shall be produced at the time of joining.
10. He/She should produce his/her two photographs of pass port size on the date of joining the post.
11. His/Her appointment will be subject to his/her being declared medically fit for Government Service by a Government Medical Officer.
12. He/She shall not have more than one wife/husband living at any time through out his/her service.
13. Other Rules and regulation not enforced herein promulgated by Government from time to time will be applicable on his/her case.
14. His/Her services shall be terminated if he/she is found to be alcoholic.
15. His/Her date of birth to be counted as an engaged date during the casual period prior to joining of date.
16. The Formal appointment order will be issued after completion of the stipulated formalities and successful completion of the probation period.
17. If He/She accepted the offer on the terms given above he/she should report duty to the office of the **Executive Engineer, Gensi Division, PWD, AP, Gensi**, within 30 (Thirty) days from the date of issue of this offer failing which this appointment will be treated as cancelled.
18. No Travelling Allowances shall be paid to the appointee, for joining his/her place of posting.
