OFFER OF APPOINTMENT TO THE POST OF SUB-INSPECTOR
OF POLICE IN CIVIL POLICE, APP.

You have been provisionally selected for appointment against the temporary vacancies of Sub-Inspector of Police in Civil Police, APP in the scale of pay of Rs. 5,500-175-9000/- plus other allowances as admissible from time to time. Your continuation in service will be subject to the following conditions :-


- I. Successful completion of basic training.
- II. Satisfactory verification of character and antecedents. On verification, if any adverse remarks are received regarding character and antecedents, your services will be terminated forthwith.
- III. The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
- IV. You will be on probation for a period of two years.
- V. You are required to serve any where in the districts and place of Arunachal Pradesh, where you are posted and detailed.
- VI. You are required to serve at least for three years under APP from the date of joining unless you are discharged or dismissed or certified by a civil Surgeon to be unfit for such service. If you resigned before the expiry of the said three years, you have to refund the cost of training and pay drawn during the period you were under training plus the expenses on T.A to join the training School.
- VII. You have to undergo police basic training at North Eastern Police Academi, Umsaw, Barapani, (Meghalaya).
- VIII. Your interse seniority in the rank of Sub-Inspector will be determined on the basis of marks secured at the time of recruitment and marks secured at the conclusion of basic training in term of circular No. PHQ/TRG/NGO/32/85 dtd. 21/05/1986.

The other terms and conditions of service which are not specified herein shall be governed by relevant rules and orders of Government of Arunachal Pradesh in force from time to time.

If you are willing to accept the post of Sub-Inspector of Police in APP in the pay scale and the terms and conditions mentioned above, you should report at Police Training Centre Banderdewa on 07/01/2004 positively for further basic training.

You should bring with you light bedding, personal clothing, one stainless steel plate(full size), one Mug (500 ml) and Rs. 1500/- (Rupees one thousand five hundred) only being mess charges etc.

In case you fail to report on the date mentioned above, your candidature will automatically be cancelled.
