ORDER

2. After joining duty she will have to take an oath of allegiance or give affirmation to the constitution of india dully in the prescribed form.
3. she will have to produce Medical certificate from the authorized Medical officer to the effect that she is medically fit for Govt. service.
4. The appointment is subject to police verification and she will be dismissed from the service with immediate effect if there is adverse remark against her in police verification.
