ORDER

In compliance with the Memorandum issued vide this office Memo No.EAC/E-1/97/Pt-1/6008-19 dtd. 31/12/2002 Chow Konseng Chowpoo is hereby appointed as Forester on probation of 2(two) years in the pay scale of Rs. 3200-85-4900- p.m. plus other allowances as admissible under rule from time to time and posted under The Asstt. Conservator of Forests, Mobile Squad, Mahadevpur under this circle w.e.f. the date he reports for duty against vacancy communicated vide PCCF's No.FOR/67/E-4/84/30834-35 dtd. 20/10/2000.

The appointment is purely temporary and on probation for a period of 2(two) years. During the probationary period his service may be terminated at any time without any notice/assigning any reasons. After satisfactory completion of the probationary period, termination from service may be effected by giving 1(one) month notice from either side. However, the appointing authority reserves the right of termination of service forthwith even before expiry of the stipulated period of notice by making payment of a sum equal to his pay for the unexpired period of notice.

The other terms and conditions which are not specified herein and in the Memorandum issued by the undersigned would be governed by the relevant rules and orders that may be in force from time to time.
