The terms and conditions of appointment are as follows:-

- The appointment is purely temporary and may be terminated at any time after giving one month notice from either side without assigning any reason. Appointing authority however reserves the right of terminating the services of the appointees forthwith or before the expiry of the stipulated period of the notice by making payment to him/her a sum equivalent to the pay and allowances for the period of notice. If the appointee wishes to resign from services or fails to give one month clear notice as above he/she has to pay one month salary in lieu of the notice period.
- The appointees shall be on probation for a period of 2(two) years from the date of joining to the post.
- The appointment carries with the liabilities to serve in any Govt. College of Arunachal Pradesh.
- Other conditions of service will be subject to his/her being found fit on verification of character and antecedents.
- The appointees shall join in the college within 30 (thirty) days from the date of issue of this order failing which his/her Appointment order shall stand automatically cancelled.

The appointment will be further subject to:-

- Production of medical fitness certificate from the Medical Board, appointed/authorized by the Govt. of Arunachal Pradesh.
