The terms and conditions of appointment are as follows:-

- a) The appointment is purely temporary and may be terminated at any time after giving one month notice from either side without assigning any reason. Appointing authority however reserves the right of terminating the services of the appointees forthwith or before the expiry of the stipulated period of the notice by making payment to him/her a sum equivalent to the pay and allowances for the period of notice.
