The appointment has been made with the following terms and conditions.

- 1 The post is transferable and liable to serve in any part of Arunachal Pradesh, where the department is having such establishment.
- 2 The final place of posting shall be done after successful completion of **3 (three) months** practical training under EE, PHE & WS Division, Itanagar.
- 3 The service will be governed by the Central Civil Services (Temporary service) 1965 as amended upto date and liable for termination by giving 1(one) month's notice or by paying equal amount of pay & allowances in lieu of notice period from either side.
- 4 The appointment has been made on probation for a period of 2(two) years w.e.f. the date of their joining at the place of posting. Further, retention of their service beyond the probation period is subject to satisfactory performance of duty during the probation period.
- 5 The appointment is subject to verification of character and antecedents and liable for termination subject to receipt of adverse report there-upon.
- 6 The incumbent must report for duty at their posting place within 30(thirty) days from the date of issue of this order, failing which the appointment order will be treated as cancelled.
- 7 The (CCS) Pension benefit of 1972 as well as allied benefits shall not be applicable to the appointee in pursuance of Development Commissioner (Finance), Govt. of Arunachal Pradesh, Order NO. DAP/PEN/11/2004, dated 17.11.2007.
- 8 The joining in service is subject to production of following documents;
 - i) The incumbent must produce a medical fitness certificate issued by Medical Officer not below the rank of CMO / DMO.
 - ii) The incumbent is to furnish oath of secrecy / oath of allegiance to the constitution of India at the time of joining.
 - iii) The incumbent is to furnish attestation form for verification of character and antecedents.
 - iv) Declaration of family members dependents duly certified by the DC / EAC / CO may be produced.

Other terms and conditions of services which are not specified herein will be governed by the relevant Rules and Orders issued from time to time.
