ORDER

Shri Oling Tatlk, S/o Shri Tagom Tatik, Village Rassam under PO & PS Pasighat, East Slang district, Arunachal Pradesh is hereby appointed as *Junior Engineer* under the Arunachal Pradesh Energy Development Agency in the pay scale of *Rs. 9300-34800 and grade pay of Rs.4200/-* per month and other allowances as admissible under Govt. of Arunachal Pradesh and is posted at Tezu, Lohit district. This appointment is subject to acceptance within 20 Days.

- 1. An initial basic pay of Rs.13500/-per month in the pay scale of Rs. Rs. 9300-34800 and grade pay of Rs.4200/per month plus other allowances as admissible under the rule shall be given.
- 2. The appointment will take effect from the date of his/her actual joining for duty at posting place.
- 3. No TA/DA will be admissible for joining against this appointment.
- 4. He/She may be granted leave under the revised leave rules 1972 as amended from time to time.
- 5. No retirement benefits like pension, gratuity under the provision of CCS (Pension) rules 1972 are admissible. Instead beneficial scheme under EPF Act is admissible.
- 6. The appointment carries with it the liability to serve in any part of Arunachal Pradesh or any Part of India on specific missions or assignments.
- 7. The appointment may be terminated at any time by at least one month notice given by either side viz the appointee or appointing authority. If however, he/she wishes to resign will have to submit resignation and wait for its acceptance by the Agency. In case he goes away without acceptance, he/she will be treated as having been dismissed from service with a disqualification for future appointment under the Agency.
- 8. Original certificates and testimonials in support of his/her qualification, age, caste/tribe should be produced at the time of joining at the posting place.
- 9. If he/she is employed anywhere he/she will have to submit a discharge certificate from his/her last employer.
- 10. In case it is proved after the appointment that qualification, age, other certificates are not genuine as required under rules, he will be dismissed from service/may be prosecuted under IPC.
- 11. In case it is also established that he/she is not a bonafide candidate and has obtained employment by direct and false representation, he will be dismissed from service and may be prosecuted under IPC.

- 12. The appointment is subject to the following conditions.
 - a) That he/she is an India National.
 - b) That he/she will not keep more than one spouse at any time throughout his/her service.
 - c) That his/her service will be terminated if he/she is found to be alcoholic.
- 13. He/she will have to take an oath of allegiance & oath of secrecy in the name of constitution of India at the time of joining at the posting place.
- 14. His/her appointment will be provisional subject to his character and antecedents being verified by the Police/District Administration of the concern districts. A medical fitness certificate from C.M.O/D.M.O/Civil Surgeon designated for the purpose is to be produced at the time of joining at the posting place.
- 15. He/she will be governed by the classification control and appeal rules etc. as framed by the Government from time to time.
- 16. He/she will not leave the Agency on offer received from any other Department where he/she might have applied before joining APEDA without permission. Also he/she will not apply direct for any post outside the Arunachal Pradesh Energy Development Agency without prior permission.
- 17. He/she will have to give his home town declaration within 7 (seven) days or on joining at posting place.
- 18. SC/ST candidates will have to furnish a certificate in the prescribed form in support of candidates claim to belong to SC/ST community.
- 19. He/she will be on probation for 2 (two) years. The period of Probation may be extended at the discretion of the appointing authority. During the period of probation he/she will be required to do such duty as APEDA may prescribe. Failure to complete the period of probation to the satisfaction of the competent authority will render him/her liable to discharge from service.
- 20. His/her appointment shall be governed under relevant rules and orders of the Government issued from time to time.
- 21. If any declaration given or information furnished by the candidates is proved to be false at any stage or if the candidate is found to have willfully suppressed any material information, he/she will be liable to be removed from service and or such other action as APEDA deem necessary.
- 22. If he/she accepts this appointment with terms and conditions given above, he/she may join for duty at posting place along with certificate of Medical Fitness, filled up Attestation form, Oath of Secrecy & Oath of Aliegiance, Home Town & Family declaration, Educational qualification from Class X onwards, Schedule Tribe certificate, release order of previous employment if any etc on or before 15th August 2016 (up to 4PM) failing which this appointment order will be treated as cancelled and next candidate who are in the panel list will be appointed.

23. Other terms and conditions not stated herein above but promulgated by the government from time to time will be applicable.
