

The appointment is made on the Staff post for the post of **PT, 180000**.

The appointment is subject to the following conditions:

- 1. The appointee shall be on probation for a period of **Three** years with a maximum of **two** extensions and be liable for periodic appraisal.
- 2. The appointment is purely temporary and may be terminated at any time by giving a **one** month notice without assigning any reason therefor if he / she leaves the service or the ministry after going to any other service or business or any other employment.
- 3. The regularisation of service shall be considered on completion of **one** year's period of satisfactory performance of duty in his / her initial place of posting.
- 4. After joining duty, he / she will have to take an oath of allegiance of attachment to the Government of Arunachal Pradesh in the prescribed form.
- 5. He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- 6. The appointment is subject to the Police Verification and he / she will be barred from government service if any adverse report is there with immediate effect.
- 7. He / she shall remain in the place of posting for a minimum period of **3** (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of **3** (three) years of service in the initial place of posting.


Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
