The appointment is subject to the following conditions:

The appointment shall be on probation for a period of 3 months, provided that he / she is fit to serve and has no medical history.

The appointment is purely temporary and may be terminated at any time by the Director of Secondary Education or by the concerned teacher himself/herself on giving notice of one month's grace period.

The regularization of service shall be considered when a person has satisfactorily performed his/her professional place of posting.

After posting duty, he / she will have to take an oath of allegiance of Arunachal Pradesh in the prescribed form.

He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.

The appointment is Subject to the Police Verification and he / she will be barred from government service if any adverse report is there with undiluted effect.

He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3 (three) years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
