- c. During contract service period he/ she is not entitled for Medical Reimbursement; Winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
- d. The contract teacher have to report his/her duty posting place within 7 days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e. He/ she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- f. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his / her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He/ She will have to undergo DIET training at the concerned DIET for training as and when called for.
