(3) The appointment is purely adhoc and may be terminated at any time without assigning any reason

(4) No TA/DA is admissible for joining the post

(5) The candidates are directed to report to respective head of office/DMO within a period of 21 (twenty one) days of issue of this order

(6) The other terms and conditions of service which are not specified herein will be governed by the relevant rules and orders applicable for adhoc service in force from time to time in Arunachal Pradesh and decision of the DHS will be final in this regard. The certificate in original (educational qualification, ST status etc) is to be shown to head of office before joining report is accepted
