ORDER

No. SPD-774/82-83 / 6926, dated Itanagar, the 19th Dec '94.

On recommendation by the Arunachal Pradesh Public Service Commission, the Governor of Arunachal Pradesh is pleased to appoint the following persons as Assistant Engineers (Elect) in Arunachal Pradesh Power Deptt. in the scale of pay of B. 2000-60-2300-33-75-3200-100-3500/- per month plus other allowances as admissible under Rules from time to time in the interest of public service. They will be on probation for a period of 2(two) years with effect from the date of joining in their respective places of posting as shown below :-

1. Shri Tapi Tai As ASW(E), CE(E), APEC-I, Naharlegun's office against existing vacancy.
2. " Okom Siram As ASW(E) in CE(Power)'s office, Itanagar vice Shri K.N. Singh, ASW(E), allowed to officiate as SW(E) in the office of the CE(Power), Itanagar.
2. " Tadaram Dorang, As ASW(E), Tawang Elect. Division against existing vacancy.
4. " Zomba Nasho, As ASW(E), CE(E), APEC-II, Pasighat's office against existing vacancy.
5. " Tami Jerang, As SE(E), created under NEC scheme, (now under proposal for shifting). Before completion of the proposal he will work under CE(Power) as ASW(E).
6. " Kenli Dzung, As ASW(E), Deporijo Elect. Division against existing vacancy.
7. " Nido Taki, As PA to SE(E), APEC-II, Pasighat against existing vacancy.

The terms and conditions of appointment will be as follows :-

1. Their services will be governed by the CCS (Temporary service Rules) 1965 as amended upto date.
2. The appointment shall be with the liability to serve in any part of Arunachal Pradesh or outside where Arunachal Pradesh Govt. Deptt. has an organisation as decided by the Government from time to time in the interest of public service.



1. The candidates will have to take an oath of allegiance to the Constitution of India and also an oath under the official secrets Act at the time of taking up appointment.
2. They will have to furnish details of their movable and immovable properties within four weeks from the date of joining. Similarly, they will also have to furnish the details of his family members.
3. Their appointment will be governed by relevant rules and orders of Government of Arunachal Pradesh issued from time to time.
4. Scheduled Caste/Scheduled Tribe candidates will have to furnish a certificate in the prescribed form in support of candidates claim to which he belongs.
5. The appointment will be further subject to production of certificate of fitness from Medical Board. A Certificate from the Civil Surgeon/District Medical Officer can be accepted provisionally.
6. The candidate should not have more than one wife at the time through out his service.
7. No 3/10 will be permissible for the joining the post offered.
8. Other terms and conditions which are not specified herein will be governed by the relevant rules and orders issued by the Govt. of Arunachal Pradesh from time to time.
