The appointment will be subject to the following condition -

- (a) This appointment is on probation for a period of 2(two) years from the date of joining.
- (b) The appointment is subject to the satisfactory report of character and antecedents. If any adverse report is received from the Police/District authority the service will be terminated forthwith.
- (c) On submission of satisfactory Medical Fitness certificate from an authorized Medical Officer.
- (d) On taking oath of allegiance/faithfulness to the constitution of India.
- (e) The appointment may be terminated at any time by a months notice given by either side, viz. the appointee or the appointing authority without assigning any reason. The appointing authority however, reserves the right of terminate the services of the appointee forthwith before the expiry of the stipulated period of notice or the unexpired portion thereof.
- (f) The other terms and conditions which are not specified here in shall be governed by the relevant rules and orders in force from time to time.
- (g) She should join within 30(thirty) days from the date of issue of this order.
