ORDER

On the basis of recommendation of DPC held on 06/05/2010 & approval conveyed by the competent authority vide U.O.No.SE/ICC/HPD/E-25/2010-11/249 dtd.06/05/2010, the appointment of Shri Sunny Sangchoju, adhoc UDC under Department of Hydro Power Development is regularized from the date of issue of this order, in the scales of pay of Rs.5200 – 20,200 + Grade Pay Rs.2800/- P.M.plus other allowances admissible under rules from time to time. He is posted in the office of the Executive Engineer(Civil), Bomdila Civil Division, Deptt.of Hydro Power Development and attached with the office of the Parliamentary Secretary(DHPD), Govt. of A.P., Itanagar.

The terms and conditions of the regularization will be as follows :-

1. His service will be governed by the CCS (Temporary Service Rules) 1965 as amended upto date.
2. He/she is required to submit an acceptance letter based on this regularization order.
3. The appointment / regularization carries with the liability to serve in any part of Arunachal Pradesh or outside where the Arunachal Pradesh Hydro Power Development Department has an organization or as decided by the Govt. from time to time in the interest of public service.
4. His / her services are liable to be terminated by the Govt. at any time without assigning any reason but ordinarily one month's notice will be given. If he / she wishes to resign he / she will have to submit his / her resignation and wait for its acceptance by the Government. In case he / she goes away without its acceptance, he / she will be treated as having been dismissed from service with a disqualification for future employment under the Government of Arunachal Pradesh.
5. He / she is required to produce a certificate of good character from a 1<sup>st</sup> Class Magistrate or from 2(two) Gezatted Officer who are known to his / her for the last 3 (three) year but not related to him while submitting his / her acceptance letter.
6. Original certificate and testimonials in support of his / her qualification age and cast should be produced again while submitting the acceptance letter.
7. In case it is proved after the acceptance of the regularization order that he / she is a dismissed employee of the union or State Government disqualifying him for future employment under the Government, he / she is liable to be dismissed from service.
8. In case it is proved after the acceptance of the appointment / regularization that qualification, age and other certificates are not genuine as required under rules, he / she will be dismissed from service and shall be prosecuted under law.
9. The offer of appointment / regularization is subject to the following conditions :-
  - a) The offer of appointment / regularization is subject to the following conditions :-

- b) He / she will not keep more than one spouse at any time throughout his.
- c) His / her service will be terminated if he / she is found to be alcoholic, subsequently.
10. He / she will have to take an oath of allegiance in the name of Constitution of India and also an oath under the Official Secrets Act at the time of submitting acceptance letter.
11. His / her appointment / regularization will be provisional subject to his / her character and antecedents being verified by the Police authorities. A medical fitness certificate from CMO/DMO/Civil Surgeon is also to be produced.
12. He / she will not apply directly for any post outside the Arunachal Pradesh or Hydro Power Development Department.
13. He / she will be deemed to be on probation for 2(two) years from the date of regularization. The period of probation may be extended at the discretion of the appointing authority.
14. If any declaration given or information furnished by the candidate proved to be false at any stage or if the candidate is found to have willfully suppressed any material information, he / she will be liable to be removed from service and or such other action as per rule.
15. If he / she accepts the regularization order on terms and conditions given above, he / she will submit his / her acceptance letter to the Superintending Engineer (Coord), Itanagar Civil Circle through respective controlling officers within 30(thirty) days from the date of issue of this order. If the candidate fails to submit the acceptance letter within the proscribed period than the regularization order will be treated as cancelled.
