Ord.No.Hort/Estt-181/09/B, Dated 07-01-3.16 for the period of one (1) year in the pay scale of PB-1, Rs. 5,200 -20200/=, plus Grade Pay Rs. 2,800/-per month plus other allowances and concession as admissible under relevant rules in force from time to time. She is posted at Kara Daadi, under DHO Kara-Daadi.

The candidate so appointed shall have to work and transferable in any part of the state and shall have to report for her duty at the place of posting within two (2) month from the date of issue of this order

The expenditure is debitable to the Head of Accounts '2401' Crop Husbandry, Sub -Major Head 001 Direction and Administration, Sub-Head - Salary Non-Plan Demand No. 48. 01 Establishment expenses detailed Head -00-Object Head-01 Salary under Demand No.48 (Plan).

The provision of officiating appointment is purely temporary and will not bestow upon the official any right for claiming continuation or regular appointment or seniority in the grade and appointment may be terminated at any time without assigning reason thereof.

The candidate so appointed shall have to work and transferable in any part of the state and shall have to report for her duty at the place of posting within one (2) Month from the issue of this order

The appointee shall have to produce Medical Fitness Certificate from authorized Medical Officer and Character Certificate from gazette officer and education qualification certificates along with two (2) copies of passport size at the time of joining duty.

The other terms and conditions which are not specified herein shall be governed by the relevant rules and orders in force from time to time.




