The above appointment is subject to following conditions :-

- 1) The appointment is temporary and on probation for two years. The period of probation is subject to further extension by the order of the Govt. The period of probation will commence from the date the candidates report for training to the Principal SFS College, Burnihat.
- 2) The Candidates should execute bond/agreement in the form prescribed by the A.P. Govt. before a 1st Class Magistrate and submit the same to this office before joining the training College. They are not allowed to attend the training college without fulfilling this condition.
- 3) The candidates must deposit an amount of Rs.400/- as Mess caution money and college caution money on the date of their admission to the college.
- 4) The candidates should report to the Principal, State Forest Service college, Burnihat within 1st Nov/88 positively no late joining is permissible as per rule.
- 5) Candidates should take Oath of allegiance to the constitution of India before a gazetted officer of Forest Department before joining training college.
- 6) During the period of training, they should abide by the rules and regulation of college authority and maintain high standard of discipline and conduct.

All other conditions which are not specified herein will be governed by relevant Rules and Regulations issued by the Govt. from time to time.


