ORDER

The services of Mr. Chow Rontu Chowlu, B.A. B.Ed. in Spl. Education (VI), Ex Resource Teacher / Volunteer is hereby considered for the engagement as Resource Person for Inclusive Education for CWSN under the head 'Academic Support through BRCs / URC', on contractual basis against the approved salary in PAB of 2017-18, at the BRC, Bordumsa, District- Changlang, in the fixed pay of Rs. 26453/- (Rupees Twenty Six Thousand Four Hundred Fifty Three) only per month under the centrally sponsored scheme of SSA.

Further, he is directed to report to the Deputy Director, Changlang District for his/her duties in the BRC mentioned against his/her name.

The engagement is subject to the following conditions:-

1. His contractual service is purely temporary and can be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
2. He has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
3. He has to submit RCI Registration number to the office of the State Project Director, SSA Rajya Mission, Itanagar within 3 month from the date of consideration of service, failing which his appointment will be treated as cancelled.
4. The Marksheets / Certificates submitted by him/her for consideration are subject to verification from original source. In case of the forged Marksheets / Certificates he is liable to face legal action.
5. No earned leave is permissible except 12 days casual leave as per central civil service leave rule.
6. During contract service period he is not entitled for medical reimbursement, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
7. The contract resource person has to report for his duty at posting place within seven days, failing which his/her engagement order will automatically be treated as cancelled.
8. He is not entitled to subscribe GPF, CGEIS or such other schemes during the period of contract service.
9. No representation will be accepted for change of posting place.
10. He will have to undergo for RPs training as an when call for.
11. The other terms and conditions of service which are not specified shall be governed by the relevant rules and order in forced time to time.
12. The engaged Resource Person has to sign an agreement for contract engagement before receiving this engagement order.


