2. The appointed shall be on probation for a period of 2 (two) years with effect from the date of joining. His continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

3. The appointment is subject to the following conditions :-

- (a) The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one month. To resign may require to give one month notice or surrendered one months salary.
- (b) After joining in the duty he shall have to take oath of allegiance of affirmation to the constitution of India in the prescribed form.
- (c) He will have to produce medical fitness Certificate in prescribed form from an authorised Medical Officer.
- (d) The appointment is subject to police verification and he will be dismissed from the service if any adverse reports are there with immediate effect.
- (e) He will have to report for duties at his posting place within 20 (Twenty) days from the date of issue of the order failing which it will be presumed that he is not willing to join the post and appointment order will stand cancelled.

4. The other terms and conditions of service which are not specified herein shall be governed by the rules and orders in force from time to time.
